Exemption Form Notes

In certain circumstances, an exemption can be granted by Scottish Government, allowing you **not** to record cattle moves between your additional holdings. You can apply for an exemption where one or more of the following circumstances exist:

- where the animals are within walking distance and are moved on a daily basis
 - We accept that there may be times of the year when you do not move cattle. Therefore, we do not expect you to move cattle every day of the year to use this exemption, however, it is expected that it will be in use for the majority of the year.
- additional contiguous land where cattle can move freely from one field to another through an open gate.
- Please enter the CPHs of the holdings between which you require the exemption in each box. An exemption can exist between your main holding and an additional holding or between additional holdings.
- Your main holding CPH allows us to find your ScotMoves registration or, alternatively, your BCMS barcode sticker allows us to scan the bar code for your main holding CPH on receipt of the exemption form.
- In the boxes representing the months of the year, please tick the months of the year the exemption will be in use.
